Trade Terms Explained — Who Pays for What

The rate above is quoted on one specific trade term. Change the term and you change how much of the journey to Brazil is already inside the price. The table below maps the eleven common Incoterms® against the twelve cost stages of a door-to-door shipment, so you can see exactly where our responsibility ends and yours begins.

- **Seller** — Cost and arrangement sit with the seller / shipper.
- **Buyer** — Cost and arrangement sit with the buyer / consignee.
- **Negotiable** — Not fixed by the rule — agree it in the contract.

EXW Ex Works

Buyer takes over at the seller's door and carries every cost from there. Lowest quoted price, highest buyer workload.

FCA Free Carrier

Seller clears the goods for export and hands them to the carrier the buyer nominated.

FAS Free Alongside Ship

Sea and inland waterway only. Seller delivers alongside the vessel; loading is on the buyer.

FOB Free On Board

Sea and inland waterway only. Risk passes once the goods are on board. The most common buying term.

CFR Cost and Freight

Seller pays the main carriage but carries no insurance obligation; risk still passes on loading.

CIF Cost, Insurance and Freight

As CFR, plus the seller must buy and pay for cargo insurance (minimum cover unless you agree more).

CPT Carriage Paid To

Any mode. Seller pays carriage through to the named destination; insurance is not obligatory.

CIP Carriage and Insurance Paid

As CPT, plus the seller must insure the cargo through to the named destination.

DAT Delivered At Terminal (DPU)

Seller delivers unloaded at the named terminal. Renamed DPU (Delivered at Place Unloaded) in Incoterms® 2020.

DAP Delivered At Place

Seller delivers to your address ready for unloading; import clearance and duty stay with the buyer.

DDP Delivered Duty Paid

Seller carries everything through to your door, duty and tax included. Highest quoted price, least buyer workload.

Two things worth flagging. Under CIF and CIP the seller is obliged to buy cargo insurance and pay the premium; under every other term insurance is optional, and we recommend buyers arrange their own cover so a loss or damage in transit is recoverable. And this table is a working summary for planning purposes — the binding definitions are the ones published by the International Chamber of Commerce in the Incoterms® rules, so confirm the exact term wording in your sales contract before you ship.

E-Commerce Freight

E-Commerce Small Batch Shipping

The 10 KG range is typical for small e-commerce restock orders and initial trial shipments. Air freight is the standard choice here — it offers the best balance of cost and speed, and most DDP air channels accept shipments from 21 KG upward. This weight falls into the LCL (Less-than-Container-Load) air category.

- Standard minimum for air freight DDP channels (most require 21 KG+)
- Common for: phone cases, accessories, clothing, cosmetics
- Amazon FBA replenishment orders at this weight use air for speed
- Declare accurate HS codes to avoid customs delays in Brazil

What Affects the Shipping Cost to Brazil?

- Actual vs. volumetric weight — carriers charge whichever is higher ($L \times W \times H \div 6000$ for air)
- Cargo type surcharge — batteries, liquids, and branded goods carry additional fees

- Peak season surcharges — Chinese New Year (Jan/Feb) and Golden Week (Oct) add 15–30%
- Destination area — Brazil may have remote area surcharges for certain postal codes
- Declared value — customs duties are calculated on CIF value

Customs & Documentation for Brazil

- De minimis threshold — shipments below local tax threshold may clear duty-free
- Required documents: commercial invoice, packing list, and accurate HS codes
- DDP service includes all import duties — you pay one total price with no surprises
- Battery and liquid goods require additional certification documents
- FDA Prior Notice required for food, supplements, and certain health products
- FCC certification required for electronic devices with radio frequency

Frequently Asked Questions

How much does it cost to ship from China to Brazil?

Current rates for shipping from China to Brazil start at USD 7,600.02/KG via Sea FCL Port-to-Port (Spot). For 10 KG, the estimated total is approximately USD 7,600, duty included. Final landed cost depends on the Import duty 10–35% + IPI + ICMS + PIS/COFINS (stacked) applied by Receita Federal (Brazilian Federal Revenue).

What duties and taxes apply when importing into Brazil?

Imports into Brazil are assessed by Receita Federal (Brazilian Federal Revenue). The applicable regime is: Import duty 10–35% + IPI + ICMS + PIS/COFINS (stacked). The duty-free / de-minimis position is USD 50 (between individuals only). Under our DDP service these charges are pre-paid and included in the per-KG price, so there is nothing to settle on arrival.

Which ports and airports handle China shipments to Brazil?

Sea freight to Brazil typically routes through Santos, Paranaguá, Itajaí, while air freight clears via GRU (São Paulo), VCP (Campinas), GIG (Rio). We pick the gateway with the best onward delivery time to your final address and price it into the DDP rate.

How long does shipping from China to Brazil take?

Door-to-door transit to Brazil: air freight 5–10 business days, sea LCL 30–50 days, sea FCL 28–45 days. On arrival, allow roughly 7–15 days of clearance/dwell at the gateway. All times include customs clearance under DDP.

When is the busy season for shipping to Brazil?

Capacity to Brazil tightens around Sep–Nov, on top of the China-side surcharge windows of Chinese New Year (Jan/Feb) and Golden Week (early Oct). Booking 1–2 weeks earlier during these windows protects both space and rate.

What is the best way to ship 10 KG from China to Brazil?

For 10 KG to Brazil, Air Freight is recommended — it gives the best speed/cost balance (5–10 business days) at this size, clearing via GRU (São Paulo), VCP (Campinas), GIG (Rio). Sea-freight minimums make ocean uneconomical under ~50 KG.

What is the minimum shipment size for shipping to Brazil?

Minimums to Brazil vary by channel: air DDP from about 21 KG (some from 12 KG), sea LCL from roughly 1 CBM, and express courier for single parcels. Below 21 KG, express is usually the most economical way into Brazil.

How is chargeable weight calculated for Brazil shipments?

We compare actual gross weight against volumetric weight ($L \times W \times H \div 6000$ for air) and charge whichever is greater, rounded up to the next kilogram. For 10 KG this matters most when cargo is light but bulky — consolidating cartons can drop you into a cheaper bracket.
